2010 SCHOLARSHIP APPLICATION GUIDELINES

- I. A parent must be employed by a member of the Missouri Limestone Producers Association and (1) must have at least 50% of his/her responsibilities related to a Missouri quarry location if employed by a multi-state company, (2) be employed by an Associate Member and work in Missouri. In addition, at least 50% of a Producer Member employee's time must be spent on the company's quarry business if it also has concrete plants, asphalt plants or other construction related activities. Sons/daughters of owners of companies are not eligible.
- II. Scholarships are limited to students enrolling in his or her freshman year. Any type of higher education is acceptable: colleges, universities, community colleges or other technical schools. Any field of study is acceptable. Student must be a full-time student carrying a minimum of 12 semester hours or equivalent with evidence of enrollment. Last year's scholarship awards were one for \$4,000, one for \$3,000, two for \$2,500 and two for \$2,000.
- III. Not more than two scholarships will be awarded to the children of an associate member.
- IV. Selection of award recipient will be based on:
 - A. CAREER GOALS:
The applicant must write a brief paragraph (space provided on application) stating how he or she expects to utilize advanced education and outlining his or her life ambitions.
 - B. FINANCIAL NEED:
Financial need and special circumstances will be considered.
 - C. EXTRACURRICULAR ACTIVITIES:
It is fitting that the applicant for this scholarship should possess an out-going personality, and who is involved with their family, community, and other school activities.
 - D. SCHOLASTIC ACHIEVEMENT:
Although an outstanding high scholastic record is not necessary to receive this award, it is essential that you have an academic background that demonstrates the ability to cope with the demands of higher education. **High school transcript must be submitted with application. If your transcript is not available when you submit the application, you must FAX it to (573) 634-8006 no later than MAY 6.**
- V. The application deadline is **May 4**. If you **do not** receive a confirmation from MLPA that we received your application, call (573) 635-0208. **Finalists for the 2010 scholarships will be interviewed by the MLPA Scholarship Foundation board on Friday, June 4, 2010 in Jefferson City.** Those asked to attend the interview will be notified of their appointment time no later than **May 21**.
